# SECTION THREE: COUNSELOR'S REPORT

Nicole Kemp, NED Counselor, presented the Counselor's Report as a powerpoint presentation during Separates Session. The following is the written report.

Greetings, Sisters of the Northeast District,

It is a pleasure to be addressing you this convention as your Counselor. I have been your Counselor for about 9 months now, and what an amazing time it has been! I hope that you all have had a positive experience with me and that I will continue to be of valued service to your chapters and to the district council over the next few years.

When I was appointed as Counselor I only had about two days to prepare before the already- scheduled Summer Council Meeting. There we laid the groundwork for how Tom and I would transition as well as for our goals and standards for the year. Kristen and I later attended the District Leadership Convention in Colorado Springs to be officially trained as leaders of Tau Beta Sigma. One highlight from the meeting was that we set the groundwork for creating a vision for the Northeast District of Tau Beta Sigma. I attended the National Convention where I was officially installed, and while our district was not represented with many numbers we surely were represented with a big voice! The NED Sisters in attendance made great contributions to their committees and we really accomplished a great deal.

As the Counselor I have created several goals for myself and for the district over my years, and I am confidently able to declare that we have made a great dent in those goals in just this one year! One of my greatest goals is to provide the tools and resources to offer leadership development and training for the council and for chapter officers as needed. Another goal is to streamline our processes, particularly in paperwork and deadlines. I of course wish to help increase the sense of excellence in our chapters (if we're talking the talk, shouldn't we walk the walk?). I hope to really open communication with Directors of Bands and Chapter Sponsors. I wanted to take the idea of strategic planning and vision development from the National Council and help forge that within the district. I value our relationships with other groups like NEDAA, TB $\Sigma$ AA, and the Brothers of Kappa Kappa Psi and I hope to further develop and cultivate mutual cooperation and respect by working closely with those groups. Lastly, I hope to be a great resource for both the chapters and the council as needed.

This year, amongst working to complete those goals, I was able to make a few personal chapter visits at the request of chapters. I visited with the Delta Omicron chapter at Clarion University, the Delta Omega chapter at Bloomsburg University, and the Eta Gamma chapter at Boston University. There I had one-on-ones with officers, reviewed and offered suggestions to programs and projects, met with sponsors and directors of bands, and helped to create SMART goals and action plans. I have been thrilled with the work of these chapters as the year went on. I am very proud of each of them in their work to meet their outlined goals.

Some highlights of the achievements of the council and district as a whole over the past year include (but are certainly not limited to): All Fall Activity Reports were submitted on time; the district council wrote a district vision statement as well as did many of our chapters; we also created goals for the next council; we streamlined many deadlines and forms and made them digital as well as having digitized the council's documents in dropbox; we were able to put some district history on the website and tracked down many

missing physical historical items (we asked Beta Eta to be the official keeper of physical history for the district, and as we create digital back-ups of these items they will be housed in the Armory at the University of Maryland); I redesigned the Counselors Award in order to push our chapters to excellence; we had an astounding amount of chapters and individuals apply for district awards; we started officer training sessions at the winter council meeting and I have designed officer training session for the forthcoming summer council meetings; I worked with several chapters one-on-one to educate them on Tau Beta Sigma policies and practices; and a true testament to the efforts of our council – there are a great number of Sisters who have announced their candidacy for the next district council, and we even have several current council members interested in rerunning for positions on the council.

I could not express well enough how amazing this council has been to work with this year during my entry into the position. They have all made my job both challenging and rewarding in the best kinds of ways. Thank you to each of them for their demonstrated leadership this year. I greatly am looking forward to working with the next council and continuing the term with great standards of excellence in the Northeast District.

Sisters of the Northeast District,

I still have a hard time believing that I am here, standing before you at the end of my term as your district president. It has been an amazing journey; one that I will likely never forget.

When I ran for this office, I stated that I wanted us to earn the title "Elite". That we shouldn't call ourselves The Nation's Elite District if we weren't doing the basics. I am happy to say that this has been a wonderful year for us. 96% of our chapters sent in their dues, chapter fees, and chapter personnel reports in on time. 100% of our chapters sent in the fall activity report. 96% of our chapters attended a precinct meeting. 48% of our chapters submitted an article to the Fall Edition of the Northeast Notes. 26% sent an article to be published in the Podium. 40% sent an article to the Spring Northeast Notes. There were 105 applications for the District Awards: Phenomenal Sisters, Unsung hero, Music Education Awareness and All-Star Service. 100% of chapters sent in delegate forms by the due date, and 85% of our chapters are in attendance at this convention.

It has taken the dedication of all of you and all the sisters who could not be here to make this happen. This is what an Elite District looks like, and we only have room to grow as we move forward into the new year.

Over the past year, I asked chapters to submit a digital workshop, to share ideas with other chapters. To date I have received 10 workshops, soon to be uploaded to the website. I know more are in the works and I encourage every chapter to continue to share ideas and experiences among each other. It has been a common theme throughout committees and workshops, that there is a demand for idea sharing year round. If you have something great to share, I urge you to share it.

Another initiative I have started is chapter vision statements. - 7. Create a list of ways that chapters, both big and small, can assist themselves and each other in recruitment, based on quality and quantity.
- 8. Discuss ways to keep MC's informed about and involved in District Events.

#### 1. Review the NED Constitution

8.201 The Expansion/Membership Committee shall be charged with the recruitment of new members and new colonies. At the discretion of the committee chair and advisor, the committee may split into an Expansion subcommittee and a Membership subcommittee in order to accomplish the goals set forth.

a. The Expansion/Membership Committee shall be responsible for the continual development of membership education according to the national guidelines, and address issues regarding membership education at the chapter and district levels. This committee will also be charged with discussing possibilities for expansion, identifying potential locations for new colonies and assisting current colonies with issues pertinent to them. This subcommittee may meet jointly with the Expansion Committee of Kappa Kappa Psi as necessary.

We reviewed the appropriate section of the NED constitution; shown above, and determined no changes were necessary.

2. Review the 2011 NED Expansion and Membership Reports

During the committee meeting we have reviewed the information in the 2010 report and determined changes where needed which are discussed below.

3. Discuss how chapters can improve participation within district membership programs.

- Communicate through the Wiggio, Facebook, email and other areas to help each chapter become more involved with district events

-- Gain more knowledge at the district level by staying in contact with the district council members. Do not be afraid to ask questions.

- Go to the events! Chapters benefit from attending precincts and districts. This a great place for them to share ideas and get a feel for district membership programs.

4. Make a list of ways chapters could improve visit/communication with school that do not have Tau Beta Sigma, in order to spark an interest in colonization.

- Plan events, service projects, and activities in the school without a Tau Beta Sigma Chapter. Help them to learn about the organization through events such as these.

- Include band members of that school in service projects for their band program.

- Appoint a "chapter buddy" who is in charge of contacting that school. Have them keep close contact between the students and facility.

- Develop a good relationship with their director of bands.

- Incorporate the use of Pen Pals.
- Have "Letter Getters" send letters to schools without a chapter. Invite them to events.

-Focus on schools with strong music programs.

- Provide a chapter workshop for the sisterhood. This workshop can include each officer discussing their office and what the job entails.

- "Mock" educator. Switch the roles and let the MC's be the teachers!

- Jeopardy, MC's Vs. the Sisters or Bigs V.s. littles

- Play "Scene it" Using ritual items and info

-Hold workshops that help evaluate the 8 and 5

7. Create a list of ways that chapters, both big and small can assist themselves and each other in recruitment, based on quality and quantity.

- Be concerned with the quality of members before being just worried about the quantity

- Include service in rush activities to see who is truly interested in serving the bands

- Recruit using things such as Facebook, posters, activities, etc.

- Create social/fun events for rush week to help potential membership get to know about the sisters

- Create a Rush video from the last semester's process and post it on Facebook for everyone to view

-Determine whether they have potential to become quality members before the yare given a bid

- Be careful not to do things "behind the scenes" too much. Be able to show band members in your school the type of things you do. Try to incorporate bigger projects and new activities.

8. Discuss ways to keep MC's informed about and involved in District Events

- Well before districts create a presentation with pictures, information, etc., that explains what districts are all about. Then, encourage them to go!

- Have sisters talk with the MC's about how wonderful their experiences were at districts

- Create a Pen Pal system at the district level to start discussions with other chapters

- Have a time management workshop at districts to really explain to the MC's how much of a time commitment it is

- Hold a workshop at districts for the MC's that allows them to talk about study tricks and tips they use to help them learn the information.

- Hold a workshop on how to resolve conflicts with other sisters during your process.

- Have the MC's go through a Chapter Operations workshop. This way they can learn about each office and how everything works within the sisterhood.

#### 1. Review the district and national constitution.

The nominations committee reviewed the following parts of the National and District Constitutions. *From the National Constitution*...

5.301 Each District shall have a District President, District Vice President, and District Secretary-Treasurer or other Officers as deemed advisable by the District Counselor. These Officers shall be elected by the chapters assembled at District Convention. The District Officers shall serve from District Convention to District Convention.

5.302 Each District Officer shall be at least a sophomore student and an active member of the Sorority in good standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that they are a Life Member by September 1 of their term in office. Each District Officer shall have exceptional business or professional ability and shall be capable of representing the Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District Officers shall serve without compensation. 5.303 A Committee on Nominations at each District Convention shall carefully investigate the eligibility of candidates for election. The committee shall nominate one member for each office and present the names to the Convention. Additional nominations may be made from the floor of the Convention by Official Delegates. The Nominations Committee shall determine the eligibility of any

other candidates who are nominated from the floor. A majority of all votes cast shall be necessary for election.

5.304 The District President shall preside at all meetings of the District and shall be a nonvoting member of all District Committees, with the exception of the Nominations Committee which she/he shall appoint, and shall render all possible assistance to the District Counselor. In the absence of the District Counselor, the District President may be designated as the official rep representative of the District whenever such representation shall be required.

5.305 The District Vice President shall, in the absence of the District President, preside at the meetings of the District. The District Vice President shall also be in charge of membership within the District as set forth by the guidelines of the District Membership Committee.

5.306 The District Secretary-Treasurer shall record, publish, and distribute to all chapters in the District, the District Counselor, and all members of the National Council, the minutes of all meetings of the District and shall, as necessary, control the receipt and disbursement of all monies of the District.

5.307 Each District Officer shall have one vote at all meetings of the District Council, except the District President. The District President shall vote only in case of a tie or if the vote is by ballot.5.308 Should a vacancy occur on the District Council, the remaining District Officers and the District Counselor shall determine the appropriate procedure to fill the office.

5.309 If a district officer's chapter is placed on suspension, the officer's status will be reviewed by the District Counselor. Any action will be recommended by the District Counselor and reviewed by the National Council. The district council and counselor must be notified within ten (10) days of any action.

5.310 Any District Officer who leaves the District permanently during the term of office shall automatically resign, and other District officers shall follow District constitutional procedure to fill the vacancy.

5.311 A District Officer may be removed from office by a unanimous vote of the remaining members of the district council and approval by the District Counselor. Upon removal from office, the National Headquarters and the National President shall receive notification of the removal within ten (10) days.

From the District Consititution...

3.2 Candidacy

- 3.201 A candidate for District Office shall be an Active member of a chapter in the Northeast District, regardless of permanent residence when elected.
- 3.202 A candidate for District Office shall have completed one (1) semester of active membership in the sorority and served as an officer or head of a committee.
- 3.203 A candidate who wishes to be slated for District Office must submit five (5) copies of the following to the Nominations Committee, one (1) copy of each must also be submitted to each delegate and District President prior to three o'clock in the afternoon (3:00pm) the first day of District Convention:
  - a. A letter of intent
  - b. One (1) letter of recommendation from the chapter
  - c. One (1) from either the Chapter's Sponsor or Director of Bands
  - d. A resume of her activities and qualifications.

3.204 A candidate must present herself to the Nominations Committee for an interview.

3.3 Elections

- 3.301 The District Council shall be elected by the chapters meeting at the District Convention. All District Officers shall serve from one District Convention to the next.
- 3.302 The manner of elections shall be by secret ballot. There shall be no abstentions.
  - a. In the event that only one candidate is willing and able to run for a given office, she may be elected by a vote of acclamation.
  - b. If acclamation fails, candidates not formally nominated, may be written in on the ballot.
- 3.303 A candidate shall be considered elected upon receiving more than fifty per cent of votes cast
  - a. In the event that no candidate achieves a majority vote, the person or persons (in case of a tie) receiving the fewest votes shall be eliminated from the election and a second ballot shall be held. This process will repeat until a candidate is elected.
- 3.304 District Officers shall not serve more than two (2) terms in the same position.
- 3.305 All District Officers shall receive reimbursement as deemed appropriate by the District Counselor and District Treasurer with the proper documentation.
- 3.306 Outgoing officers shall relinquish all material connected with their respective offices to the proper incoming officers and shall perform an orientation with those officers no later than one (1) week after the close of District Convention.
- 3.4 Duties
- 3.401 The responsibilities of the District Council shall be as follows:
  - a. To travel and visit chapters.
  - b. To correspond with National, District and Chapter officers on a regular basis.
  - c. To attend and run Precinct workshops.
  - d. To write articles for The Podium and "Northeast Notes."
  - e. To execute any other projects that the District Council undertakes.
  - f. To submit a report of activities conducted during their term of office at each regularly called District Convention.
  - g. To submit an activities report for each issue of "Northeast Notes."
  - h. All district officers are required to submit proper paperwork for reimbursement as deemed appropriate by District Counselor, District Treasurer and Nationals.
- 3.402 The responsibilities of the District President shall be as follows:
  - a. To request applications for the Convention Parliamentarian no later than two weeks prior to the first Precinct Meeting, and to appoint the Convention Parliamentarian on the Monday following the last Precinct Meeting.
  - b. To request applications for the District Webmaster no later than two weeks prior to District Convention, and to appoint the District Webmaster within two weeks following District Convention.
  - c. To supply committee chairs with tentative charges at least thirty (30) days prior to the Convention.
  - d. To supply each chapter with one (1) copy of all tentative charges at least twenty-one (21) days prior to the District Convention.
  - e. To attend the District Presidents' meeting prior to National Convention and sit as the Northeast District Delegate at the National Convention, or to attend the National Summer Conclave Meeting at the National Headquarter, dependent on the year in office.
  - f. To send Candidates for District Office candidate information and District Office information material at least one (1) month prior to the District Convention.
  - g. To award the Most Improved Chapter and the 50<sup>th</sup> Anniversary Spirit Paddle at each Northeast District Convention. The qualifications for these awards shall be left to the discretion of the District Council.

- 3.403 The responsibilities for the District Vice President of Membership shall be as follows:
  - a. To work with the Tau Beta Sigma National Vice President for Colonization and Membership and the District Vice President of Kappa Kappa Psi towards expansion within the District.
  - b. To administer all programs concerning membership education.
  - c. To serve as advisor to the Expansion Committee.
  - d. To notify chapters semi-annually regarding colonization processes within the District. The Vice President of Membership is also responsible for communicating dates of colony degrees to all chapters within the District at least two (2) weeks prior to the degree.
  - e. To collect and review chapter Membership Education Packets for input and future reference.
  - f. To provide chapters with information on creating and/or purchasing ritual items
- 3.404 The responsibilities of the Vice President of Special Projects shall be as follows:
  - a. To make available to chapters all award applications, select the winners, and announce them at District Convention.
  - b. To work with the District Vice President of Kappa Kappa Psi to arrange Northeast District Days.
  - c. To compile and distribute to each Northeast District chapter a list of Service Project ideas, and to maintain a Service Projects binder.
  - d. To serve as advisor to the Programs Committee.
- 3.405 The responsibilities of the District Secretary shall be as follows:
  - a. To keep a current roster of the District as obtained from the National Headquarters.
  - b. To collect summer contact information from each chapter in the District for distribution to all District Officers and the District Counselor.
  - c. To distribute a roster including addresses and phone numbers of all chapter Presidents and/or Secretaries within the District to the chapters, no later than October 1.
  - d. To provide documented notification of the District Convention dates to all chapters in the District, their Chapter Sponsors, the District Officers, the District Counselor, NEDAA, the TBSAA, the National Officers, the members of the Board of Trustees, and the National Headquarters at least ninety (90) days prior to the close of registration.
  - e. To notify all chapters by February 1<sup>st</sup> that a yearly Chapter Report must be submitted by the chapter Delegate at the Northeast District Convention.
  - f. To record and publish the minutes of the District Convention and to distribute these to all chapters in the District, the District Officers, the District Counselor, the National Officers, and the National Headquarters no later thirty than (30) days following the close of convention. According to the Table of Contents, the District Minutes should include:
    - i. Separate and Joint Session Minutes.
    - ii. Award Recipients.
    - iii. Committee Workshops.
    - iv. Counselor's Report.
    - v. District Officers' Reports.
    - vi. Yearly Chapter Reports.
    - vii. Delegate Committee Assignments and Committee Charges.
    - viii. Separate Committee Reports.
    - ix. Joint Committee Reports.

- g. To award the Golden Typewriter Award at each Northeast District Convention. The qualifications for this award shall be left to the discretion of the District Council.
- h. To collect Materials from the seated proxies immediately following the closing joint session and to send those materials to the respective chapters within one (1) week of the close of the District Convention.
- i. To revise and publish the Chapter Operations Materials Binder, paying special attention to the table of contents page, and introduction, which will be sent to the chapter presidents at the chapter address by September 15<sup>th</sup>.
- j. To assist in improving inter-chapter relations.
- 3.406 The responsibilities of the District Treasurer shall be as follows:
  - a. To keep an itemized report of receipts and disbursements to be included in the yearly report.
  - b. To act as advisor to the Ways and Means Committee.
  - c. To organize and implement District fundraisers.
  - d. The Treasurer shall submit a current budget update and the proposed budget for the next year to the District Counselor, the District President, and the Ways and Means Committee at District Convention.
  - e. To submit a separate end of the year fund-raising report to the Ways and Means Committee, stating the fund-raising projects undertaken during the year and their effectiveness.
  - f. To collect the Delegate Fee by the start of District Convention and implement a late fee of five (5) dollars if deemed necessary.
- 3.407 The responsibilities of the Alumni Secretary and Historian shall be as follows:
  - a. To gather and distribute information regarding application to the TBSAA, NEDAA, and local alumni associations located within the Northeast District and Life Membership.
  - b. To communicate with each chapter's alumni contact regarding guidance of graduating seniors, ways to involve and contact alumni, and resolving difficulties with alumni.
  - c. To communicate with each chapter's history contact regarding historical archives to research and update chapter history.
  - d. To create an alumni resource containing instructions and advice on local alumni associations, NEDAA, Life Membership, alumni communication, and alumni events.
  - e. To act as a liaison between the NEDAA, District Council, and actives.
  - f. To act with the Kappa Kappa Psi counterpart to improve alumni relations on a joint basis.
  - g. To work with District Webmaster to create and maintain a page on the district website with the information contained in the items above.
  - h. To compile, enlarge and maintain a Historical Archive of the Northeast District.
  - i. To collect a copy of the most current District Convention Minutes and Constitution to include in the Historical Archives.
  - j. To be responsible for providing access to the Historical Archives upon request.
  - k. To be responsible for collecting and compiling information from the past academic year for addition to the Historical Archive.
  - 1. To be responsible for collecting and compiling information for a presentation in the form of a slide show to be displayed at that year's District Convention.

- m. To serve as the advisor to the Alumni and Historical Affairs Committee, and to invite a representative of NEDAA and TBSAA to be present at the Committee meeting.
- 3.5 Removal and Replacement

3.501 Should the office of District President be vacated for any reason, the District Vice President of Membership shall automatically succeed to the District Presidency until the following District Convention.

- 3.502 Should the office of the District Vice President of Membership, District Vice President of Special Projects, District Secretary, District Treasurer, and/or the District Alumni Secretary and Historian be vacated, the District President and District Counselor shall appoint the new officer. Any appointment shall take place no later than thirty (30) days after the office in question has been vacated.
- 3.503 Any District officer may be declared unfit for office by a majority vote of the District Council. Any Officer who is so declared shall be immediately relieved of her duties. All active chapters shall be notified of this action.
- 3.504 In the event that a candidate will go from active status to alumni status during their term of office they must obtain Life Membership within 60 days of their change of status.
  - a. In the event that the candidate does not obtain Life Membership within 60 days of their status change, they must relinquish their position.

After reviewing the district and national constitutions we found the following recommended changes to be presented to the Jurisdiction Committees.

- 1. Strike 50th Anniversary from the phrase "Award...the 50th Anniversary Spirit Paddle..." (3.402 g)
- 2. A district officer may be removed by "unanimous vote of the District Council." This is changed from "majority vote of the District Council" This is to reflect what is stated in the National Constitution. (3.503)
- 3. Candidates must submit six copies of their packets to Nominations committee. (3.203)
- 4. Change the time that packets are due to the close of opening separate session on the first day of convention.(3.203)
- 5. Add the stipulation that If in the event the Candidate may miss opening separate session, she may mail the copies of her packet to the District President. (3.203)
- 6. Require that a summary page that explicitly lays out a Candidates eligibility in respect to the District and National Constitutions. (3.203e)

c. One (1) from either the Chapter's Sponsor or Director of Bands

The Candidate also must submit her completed packet electronically to the district one (1) week prior to District Convention.

Alumni Affairs

The 2012 Alumni Affairs Committee was charged with the following:

- 1. Discussion on how to communicate with alumni (activities, ideas, etc.)
- 2. Review NEDAA and any new activities
- 3. Review duties of the Alumni Secretary/Historian
- 4. Discuss ways to get alumni to purchase life membership if the price increases
- 5. Review projects of the Alumni Secretary/Historian
- 6. Review alumni workshops at precincts and district convention

The Alumni Affairs Committee addressed the charges as follows:

The committee had a great discussion on how to communicate with alumni. Committee members talked about connecting to alumni through Facebook groups and listservs, hosting family dinners, engaging in Alumni pen pal programs, and having Alumni picnics and tailgates. Members of the committee agreed that this discussion was a great way to get ideas from each chapter and expressed desire in continuing this charge for next year.

In review of the NEDAA and new activities, it was discussed that the NEDAA had mostly focused on internal operations this year, such as setting up a bank account, updating their website, reviving their newsletter, and creating the smart phone app and Twitter. The committee did express gratitude in the continued activities of the NEDAA, such as the keynote speaker contest, providing flags to newly installed chapters, and providing workshops at conventions. The platform workshop that occurred this year was thought to be very beneficial. There was discussion about having the NEDAA expand their flag-providing program to provide more regalia to chapters in need. The main idea was for chapters to write to the NEDAA for their intent for new regalia, and the NEDAA would decide upon and provide funds for one chapter each year. The committee also expressed interest in having the NEDAA provide a networking database for both actives and alumni.

In review of the Alumni Secretary/Historian, the committee decided upon continuing some charges for the office from last year, such providing the fun fact trivia and information about the NEDAA on the district website. The committee appreciated the NED yearbook and would like to see it continue next year as a joint NED yearbook. This would promote the Alumni Secretary/Historian to work with KKPsi counterpart. In addition, in order to improve the joint relations, the committee suggested having a workshop about working with a joint counterpart. Committee members also expressed interest in seeing the Alumni Secretary/Historian provide more history workshops at conventions. As for digitizing and restoring NED documents and materials, it was discussed that perhaps other chapters should be asked to see if they would be able to help, since this is a rather large task.

In discussion of life membership, there was talk of a scholarship in a chapter that helps pay for life membership. This brought discussion that perhaps chapters should find a way to incorporate life membership for graduating seniors in their budget. Committee members also brought up the idea of implanting a payment program so graduated sisters wouldn't have to pay the total amount at once. However, this could bring about logistical problems in deciding how long the program would be and when the sister would have obtained life membership. Overall, it was decided that there needs to be more incentive for life membership, such as

through establishing stronger relations between actives and alumni and providing more opportunities for alumni during conventions, like beneficial workshops and alumni bonding events (i.e. scrapbooking).

In review of alumni workshops, the committee decided that they would like to see alumni workshops continued as they provide great resources and incentive for remaining involved. Possible workshop ideas included information about life membership and alumni associations, how to create an alumni association in your district, and resume building.

The Alumni Affairs committee charged the next NED Alumni Secretary/Historian with the following:

- 1. Work with Webmaster to provide easily accessible information about NEDAA and TB $\Sigma$ AA on district website
- 2. Work with alumni associations to create and send survey for alumni to evaluate respective workshops at conventions
- 3. Work with KKPsi counterpart to create a joint NED yearbook
- 4. Continue to provide fun fact trivia and other district history activities
- 5. Continue to award and pass on NED History/Award
- 6. Correspond with other chapters to see if they are willing to help digitize and restore NED documents and materials
- 7. Promote/provide more history workshops at conventions
- 8. Work with TB $\Sigma$ AA to create a database for NED alumni, graduating seniors, and students looking for internships
- 9. Work with NEDAA to provide a scholarship for chapters in need of regalia

The 2013 Alumni Affairs Committee is charged with the following:

- 6. Discussion on how to communicate with alumni (activities, ideas, etc.)
- 7. Review NEDAA and any new activities
- 8. Review projects of the Alumni Secretary/Historian
- 9. Promotion/education/increase incentives of life membership, NEDAA, TBΣAA, and other alumni associations
- 10. Review alumni and history workshops at precincts and district convention

## Special Committees: Vision and Direction

Chaired by Alana Leeti – Zeta Upsilon Advised by Kristen Ulloa – Eta Sigma, NED President '11-'12 The 2012 Vision and Direction Committee was charged to:

- 1. Review the NED Council's proposed vision.
- 2. Discuss any changes to the vision.
- 3. Finalize the NED Vision Statement.
- 4. Review the goals set forth by the 2011-2012 Council for the 2012-2013 Council.
- 5. Propose any changes or additions to the goals for the 2012-2013 Council.
- 6. Discuss any suggestions for future ad hoc committees.

1. The NED Council proposed the following Vision Statement; "The Northeast District of Tau Beta Sigma is a growing Band organization that celebrates diversity within our chapters across our district. Sustainability and expansion are continuous due to our welcoming bond, strength of education process, and lifelong support of one another. We are elite. Our work within Tau Beta Sigma as a district and as individual chapters fosters excellence in band programs and upholds the initiatives of the national chapter. The sisters of the northeast district work in full cooperation with our brothers of Kappa Kappa Psi as well as all other musical organizations. We pride ourselves on our stability, independence, and resourcefulness."

Overall, the committee felt that this was a good start. It hit the main points that we feel encompass the direction the Northeast District should be headed.

2. The committee felt that the line, "We are elite" seemed out of place. As a whole, the committee liked the line but felt that the placement broke up the vision statement too much and did not have a strong enough effect. After trying it in multiple locations the committee decided that the line would flow best at the end of the vision statement.

The sentence, "Sustainability and expansion are continuous due to our welcoming bond, strength of education process, and lifelong support of one another." was rearranged so that it begins with, "Our welcoming bond," the committee felt this gave the statement a better flow.

The sentence, "Our work within Tau Beta Sigma as a district and as individual chapters fosters excellence in band programs and upholds the initiatives of the national chapter." was altered so that it reads, "As individual chapters and as a district, we work within Tau Beta Sigma to foster excellence in band programs, to provide service to our communities, and to uphold the initiatives of the National Chapter." The committee also reversed the order of these two sentences.

After comparing with the national vision statement, the committee decided to work in lines about communities and leadership. The line "to provide service to our communities" was added in. The committee added the word "leadership" to the sentence, "We pride ourselves on our stability, independence, *leadership*, and resourcefulness." The committee also considered and replaced a number of words with synonyms that seemed to have more of an impact.

3. The committee voted and agreed on the following as the new Vision Statement for the Northeast District of Tau Beta Sigma; "The Northeast District of Tau Beta Sigma is a growing band organization that celebrates diversity within chapters across our district. As individual chapters and as a district, we work within Tau Beta Sigma to foster excellence in band programs, to provide service to our communities, and to uphold the initiatives of the National Chapter. Our welcoming bond, strength of membership education, and lifelong support of one another allow us to maintain and expand our Sisterhood. The Sisters of the Northeast District work in full cooperation with our Brothers of Kappa Kappa Psi, as well as all other musical organizations. We pride ourselves on our stability, independence, leadership, and resourcefulness. We are elite."

4. The 2011-2012 NED Council proposed the following goals for the 2012-2013 NED Council;

- Band Service, efficiency/expansion of current projects
- Pen pals

5. The committee discussed each goal on the list and determined how significant each was to the future of our District.

The committee suggests that the 2012-2013 Council focuses on the following goals;

  - o Visits/Traveling

The committee felt that pushing National projects as a whole should be a goal rather than the individual projects. This encompasses National Intercollegiate band, Women in Music speakers and working with Girl Scouts.

Being that we are a band service organization we feel as though we can never have enough band service. The council as well as the chapters are to continue providing exceptional service to bands and always be pushing for ways to improve these projects.

Chapter interaction is another big goal. Talking to one another is a great way to get new ideas and problem solve as well as bringing us closer as a district. This interaction can take place in a few forms such as visits and District Daze. Pen pals are another effect way of interacting with another for times we are not able to meet up in person.

Along with visiting other chapters, the committee would like to see visits with non chartered schools continue. It was suggested that we began by simply attending their band concerts and show them how we support the band.

We decided against allowing chapters run from the floor to allow for thorough and complete packets.

Additionally, the issue of a change in convention schedule was brought to the committee. It was decided that this was not an issue for the committee. Instead the decision lies with the Joint Councils with the advisement of the host chapters.

Due to the lack of complete bids we recommend to the councils and jurisdiction committees to move the deadline for bid submission to one week before opening gavel of District Convention. We encourage chapters to submit bids at the precinct meetings to allow more time for review of bids.

## SECTION ELEVEN: CHAPTER REPORTS

Each chapter is asked to submit a one-page review of their activities from the past year. The following reports were received by the opening gavel of separates session.

## Beta Eta

University of Maryland Actives: 22 Conditional: 2 Membership Candidates: 4 Service:

Beta Eta starts our year of service by doing many things to help the marching bands early week run smoothly. On the first day we help with member sign in and give out early week survival kits to the members. Halfway through the week we put on the Hump day Dance which is a fun time for everyone and includes the sisters and the brothers stepping and the first time the band trucks. After early week we continue to help the band throughout the semester by helping to set up and strike the field before and after practices as well as racking and stacking during any indoor practice. During the fall we also hold penny wars where each section in the band donates money and tries to be the section with the most points. All of the money raised goes to a high school in the area that we have decided to support for the year. This year we decided to split our support by sending the money to North Caroline High School on the eastern shore while visiting and playing in the stands with North Carroll High School. This was a great way for us to influence several band programs this year. To conclude the fall semester we put on a male beauty pageant, Mr. MSOM during this event we collect cans that are then donated to charity. This semester we plan on trying to host a girl scout event and possible a women in music day with SAI. Also we took water to the pep-band for both a women's game as well as a men's game.

Membership:

Each year Beta Eta puts two classes through, one in the fall and one in the spring. Our fall class was 4 people last semester and we currently have 4 mcs. For rush we do a game/ movie night where sisters and the prospective play board games. Our second rush event was girls night which was a new event we added in the fall and has been a lot of fun. The sisters and prospective get together and do each other's hair, nails, and makeup which watching a chick flick. Our final event is our most popular, Chocolate Fantasy Night. We also do a joint bbq with the brothers and their prospective.

#### Fundraising:

This year our main fundraising has been done jointly and has generally gone to joint as we have been preparing for districts. We work for FMI at Ravens and sell merchandise. We have also done several restaurant fundraisers and a Date Auction.

## Gamma Chi

This past year we have fundraised money for the Marching Band. The Marching Band has been invited to play in the 2012 Summer Olympic games in London. One of the fundraisers we had was selling bracelets for the trip.

This past year in service we have done a few things around our music building. Steadman Theatre, where we have all of our concerts and recitals, is a stadium style theatre with raised seating. On each of the steps there are strips of yellow caution tape but because of normal wear, it became hard to see the tape. We took the time to re-tape each of the stairs in the theatre.

We have done the normal things we do around the building when it comes to cleaning. We clean the banisters, door knobs, windows in all of the practice rooms and professor's offices, and take down all old posters. Recently we've picked up a new job which is watering the pianos. Mansfield is in the process of switching over to an all Steinway school. The newer pianos have to stay hydrated and we go around and make sure that is done.

For a local school, Southern Tioga in Blossburg, PA, we bought a baritone for the marching band. The school has a small budget and some of their marching instruments are in poor shape. We weren't allowed to donate money directly to the marching band, so we decided to put the money we raised towards something they needed, which was that instrument.

We have had major improvements this year when it comes to membership. Our Vice-President of Membership, Rochelle Carlisle, is putting on quite a membership process this year. She has taken the time to completely change the way we run our membership process. It used to be that we had to memorize everything in our books such as the 8 and 5, Mission Statement, Vision Statement, Preamble and 5 Purposes to the Constitution, Our Mansfield Band History, National Address, National Phone Numbers, etc. The only things we want to see memorized now out of that entire list is the 8 and 5 and the Mission Statement. It makes it sound like there's less to do during the process but she added a lot more content. Our Membership Candidates seem so eager to learn all that they can. She also has a lot of the other info for post-membership sessions.

Besides putting on the Membership Candidate process for the MC's, she is also putting on another separate process for the rest of the sisters. We were debating on not taking a class this year but we decided that it would be beneficial to take a class for membership sake. We realized that our chapter is small enough where we can take the time to put MC's through the process and help them become great sisters while also working on our bond and strengthening ourselves as sisters. It has been going very well so far!!

As for activities, we've done some pretty fun things. We just had a 25<sup>th</sup> Birthday Party for the Northeast District! We've also had letter making parties, we made valentines, and we even made our own ice cream and watched a movie for our senior send-off. Each meeting we take the time and do mad-libs where each sister fills in a different blank and then it's read to us to see what we came up with. We also do a secret sister exchange for the whole semester. We get a sister's name in the beginning of the semester and for the rest of the semester, we surprise them with random things like inspirational notes or nice gifts.

#### Gamma Kappa

The Gamma Kappa chapter of Tau Beta Sigma at the University of Connecticut has had quite the year so far. Coming into the fall semester at 33 active members, Gamma Kappa didn't take long to make a decisive and altering change. We discussed with just our chapter and also with our brother chapter of Kappa Kappa Psi and decided to forgo taking a class for the Fall '11 semester and instead evaluate our process, service, and what it means to be a sister. This proved incredibly successful as we were able to refocus, rededicate ourselves to service, and it brought every sister closer in the bond.

As the fall semester came to a close, and we began looking at taking a class, Gamma Kappa decided upon another shattering change: we decided to hold a letter getter meeting for our incoming class. This had been employed by our brother chapter, though we had never heard of any of chapters of TB $\Sigma$  taking this approach. As this had already been a highly experimental year for us, we decided to try it out. Upon receiving letters, our potential MC's were told there would be a meeting they could choose to attend with the whole chapter to clear up any questions they had, all before they had to make their final decision. We had our whole chapter sit in a circle with everyone who had received letters intermingled, and asked if they had any questions. If the potentials were shy, the sisters would ask questions that might relevant, such as "Will this process affect my grades?" Our chapter decided this was a huge success, as the majority of the people who were given letters came, and many have since said that the letter getter meeting convinced them they wanted to join our chapter. The chapter as a whole still didn't know who had accepted their letter and would show up to 1<sup>st</sup> degree, but we were able to further interest them once the letter was given. We now have 10 wonderful M.C.'s in our Gamma Alpha class, who have swag out the roof.

Our fundraising has been just as solid this year as any. We have kept up our Rose Sales, where we sell roses before and after most of the larger music department concerts with all of the proceeds going towards a music scholarship for an incoming student. Gamma Kappa also helps set up the theater at our performing arts show before most of the major pay-to-watch shows, and in return we get payment for our organizations. These "chair set-ups" are a huge source of our income, and also offer a great deal of sisterhood bonding. Together with the brothers, we held the first ever UCMB Pie day. We set prices to pie section leaders, drum majors, graduate assistants, and even our assistant director, only after they volunteered of course. This was incredibly successful because we were able to make a good bit of income at very little cost. The best thing was, the whole band enjoyed it. Thanks to fundraising this year, we have been able to donate towards the UCMB's ALS fundraiser, fund receptions after concerts, and will soon be offering a scholarship to a future music student.

This year has also been a great year of service for our chapter. We decided to take two service chairs under our Vice President of Service to help with delegation and make sure we could take advantage of every single possibility. During our semester off from taking a class, we were able to have focus groups and discussions about how we could improve our service in various areas, such as on game-days, during rehearsal, and in the music department. We helped Manchester High School Marching Band with their marching and field awareness several times, and for one marathon session on a competition Saturday. Our music department has recently gotten more involved with the high schools around the state, and Gamma Kappa has been there to volunteer at the Eastern Regional concert, as well as the selective Honor Band concert. We have been involved in Uconn's Huskython, and 18 hour dance marathon, helped hold a coffee house, and are

currently in the process of raising money for the MS Walk. The major project we're trying to get off the ground is an a cappella benefit concert held at our campus' largest performing arts theater.

Overall, progression is the only way to describe the year so far for Gamma Kappa. We tried out several new things, and loved how they worked out. We are continuing to grow our fundraising efforts and the amount of service we do, and the UConn Marching Band as a whole has never been better. It has been one great year for our chapter, GKFTW!

#### Gamma Omega

The Gamma Omega Chapter of  $TB\Sigma$  has been hard at work all year to aid the band and the community. We had 7 MCs during this year, and they have worked extremely hard within the sorority and within the band.

There have been many exceptional service projects we have been involved in. Once again we have worked with the Pittsburgh Symphony to present Fiddlesticks to the community, a morning long workshop that teachers younger kids the value of music. In addition, we presented both Pitt Band Birthday and Pitt Band Thanksgiving to the band, which convey a feeling of family within the band and helped raise money for the local women's shelter. We will be participating in Relay for Life in a couple of weeks as well. Finally, we are currently preparing for the Pitt Band Centennial celebration, which will involve an instrument petting zoo, a concert, banquet, and a Pitt Band history museum.

Fundraisers have been very lucrative this year, allowing us to do more within the band and for the upcoming centennial celebration. Such fundraisers include hoodie sales for the Pitt Band centennial, carnation sales, plant sales and candy bar sales, and have allowed for greater financial stability.

The Gamma Omega chapter has emphasized the aspects of sisterhood throughout the year. Our spring class began their process a few weeks ago. We are currently taking a class of eight young ladies. So far they are all doing very well with their requirements. ## NORTHEAST DISTRICT ALUMNI ASSOCIATION PRESIDENT'S REPORT TO JOINT SESSSION 2012 NORTHEAST DISTRICT CONVENTION UNIVERSITY OF MARYLAND

As we reflect on the 25th Anniversary of the Northeast District, one thing I can't help but think about is the theme of "Change." And so, while I'll go over some of NEDAA's highlights over the past year, rather than give you a laundry list of activities, I thought I'd take a few moments to talk about what change has been for me as an Alumnus, and probably for Alumni and Alumni Associations.

At a KKPsi Alumni Communication workshop at Southern Precinct and at this morning's Kappa Kappa Psi Alumni Association roundtable, Advisory Committee Chair Ed Savoy correctly pointed out that, when I was initiated back in 1990, policies on alcohol, hazing and Alumni involvement were either nonexistent or in their infancy. Today, such policies and practices are firmly in place. Once, there was one National Alumni Association; it broke down, but today, we have the Kappa Kappa Psi Alumni Association and Tau Beta Sigma Alumni Association. The NEDAA, started in 1987 as the District IX Alumni Association of Kappa Kappa Psi, was originally Brothers-only and probably involved only Alumni from a few schools. Today, we are a joint organization with Alumni membership from more than a dozen schools spanning the entire District.

#### Things change.

Sometimes change is forced externally—by necessity, if course correction is needed. But I've found that often the most productive change is the kind that is sought out, embraced. But it is now time for me to take a break and take better care of myself professionally, personally, and physically, and for others to take the mantle—new faces, fresh ideas.
