Beth Bronk, Associate Professor, is in her tenth year as Director of Bands at Texas Lutheran University, where she teaches conducting, instrumental music education courses, and directs the TLU Bands. Professor Bronk earned her Bachelor's degree, Performance Certificate, and teaching certification at the University of Texas at Austin, and Masters degree in Trumpet Performance from the University of North Texas. She is nearing completion of her doctoral work at Teachers College, Columbia University. Her dissertation is titled, "Director Expertise in Teaching Intonation." Before joining the faculty at TLU, she completed eighteen years of public school teaching and administration, primarily in the New Braunfels Independent School District. She continues to serve the Texas Music Educators Association as the president of Region 12 and is currently the Vice-President for Professional Relations on the National Council of Tau Beta Sigma. Her in-service presentations and clinics focus on continuing professional growth and education for band directors at all levels of experience. In December, Prof. Bronk was given TLUs 2015-2016 Distinguished Faculty Award for Service and Leadership. Ms. Bronk is an active clinician, adjudicator, and performer.

The NEDAA Alumni Communication Award - presented by Jasmine Johnson, NEDAA Vice President for Tau Beta Sigma. It was awarded to KKPsi - Iota Phi at the University of New Hampshire and TBS - Iota Pi at Lincoln University.

The NEDAA Keynote Speaker Award - presented by Sarah Fitzgerald, NEDAA President. It was awarded to Shomahri Simmonds, KKPsi- Iota Xi at Norfolk State University.

SECTION THREE: COUNSELORS' REPORT

Dear Sisters of the Northeast District,

As a freshman, I remember sitting at NED Convention 2012 at the University of Maryland. As I watched Allison Leemann be elected NED President, I said to myself, "I want to be that." As such, it is with great honor that I am giving this final report as your President. I can not explain how the journey that I have taken within the Northeast District has changed my understanding of TBS and how it has changed me as a person. I'm going to try to keep this to strictly my Presidency, and not my three years as a District Officer.

I was recently asked by a good friend "do you believe you have accomplished your goals?" and I said "no" but not in a bad manner. I am incredibly proud of the work I

have done, And I am incredibly proud of the work that this Council has done, Furthermore, I am incredibly proud of the work you all do on a daily basis. I said no because it doesn't end here (where have we all heard that one?). When I ran for President, I ran off of the idea of creating programs and activities that promote district unity. That included breaking down barriers that prohibited us from having serious conversations, not only about what a chapter does, but what is going on around us, and how we can best address it while still providing exceptional service to collegiate bands. This also means that the District Council would have to create spaces for people to get to know one another outside of our annual Precinct Meetings and District Convention. It's one thing to hold a group chat on Facebook to talk about a topic. It's another to see someone talking to you face to face, hence why I wanted to launch the NEDTalks and Task Force campaigns. I highly encourage everyone to take advantage of the resources that we have online.

In June 2015, the District Council met in Washington DC for our Summer Meeting, and through that we created four goals that we wanted to work towards throughout the year. Step by step, I want to take you through my thinking on what we have accomplished this year.

"Develop new programs while enhancing other ones"

One of the biggest activities that we did this year was through a "We stand for...." campaign during National Hazing Awareness Week. We decided to eliminate a district program to promote a similar National Program, and better enhance Project Good Member to increase participation.

"Develop leaders to continue to serve collegiate bands"

By increasing the amount of opportunities for Sisters to get involved on a District level, they are gaining more wholesome perspectives of Tau Beta Sigma. These perspectives make them a better leader that is able to work with a more diverse range of people. I saw this with the NEDTalks attendance, Convention Committees, and student run workshops.

"Establishing clear expectations to encourage growth and development"

By setting clear expectations with our MEPs, our Constitutions, and the sorority policies, we are making ourselves stronger. It was during her President's vision that Kathryn Kelly made it clear that when our values as a sorority increase, we let

Sisterhood ring and have a uniform understanding of what our policies state. When a policy had to be communicated, it would be sent to everyone's email, but the opportunity to have a conversation about it would always be available.

"Unifying through a mutual understanding and respect for each other"

I remember when I gave my two minute speech during elections, I specifically mentioned that we have many different schools in our sorority, with the most obvious being the differences between predominantly white institutions (PWIs) and historically black colleges/universities (HBCUs). Each school has its own culture, and instead of mandating a certain way to run a membership process, or how to run a chapter meeting, we should let our cultures shine and make each chapter unique. When we're not afraid to be our unapologetic best selves, then we can start to unify. When we're afraid to be ourselves because of the threat of racism, or sexism, or homophobia, (or all of the other isms in the world) we can't be at our best. We must be able to have those seemingly uncomfortable conversations to push ourselves to be better. What I've learned through Tau Beta Sigma is that you are never at your best, there is always a way to become a better person. That goes for chapters as well, chapters are never at their best because there's always ways to improve and push yourself to the next level.

Being District President, I have the honor of attending District Leadership Conference, and because it was an odd number year, I was able to sit as the Northeast District at National Convention. Through these experiences, I got to know so many people both in and outside of the NED. During DLC, I was with the other District Presidents throughout the course of a few days and got a glimpse into the other districts. And, besides the amazing friendships that I made along the way, it only affirmed that we are all alike. We experience chapter struggles, we have our different favorite parts of the sorority, we have the same types of stresses just in different forms.

I love email as much as the next guy, but I wholeheartedly prefer a phone conversation more. I set a goal to talk to someone from each chapter on the phone at least once throughout this past year, even if it was a quick question. As of today, I completed that goal with the Eta Chi chapter being the last one. I have spent countless hours on the phone talking about chapter operations, sorority policies, or how much this sorority has changed a person's life. Whether it be answering a quick question from a chapter, or talking with NEDAA on how they can better serve our actives, or talking with a chapter president about a chapter member/officer. Many of these conversations were prefaced with "this may not be important" or "I'm sorry that I'm bothering you." Whatever conversation it is, you are not bothering and whatever you need to talk about is important. I was elected to be your President to be among that group of people to answer the phone at 10pm to address your concerns or answer your questions. Frankly, I have loved every single conversation that I have had with each of you.

Sidenote: Your District Council is here for anything you need, and this year I noticed an increased willingness to talk, but that can't stop because of a change in leadership. It needs to continue.

The following committees were active at district convention and have submitted oral reports to the delegation along with their written summaries below: Counselor's Award, Membership, Nominations, Programs, Ways and Means, Sisterhood and Spirit, Jurisdiction, and Joint Convention Site and Publication.

Counselors' Award Committee - March 18th, 2016

Our committee had the privilege of recommending the recipient of the 2016 Counselor's Award. Every Tau Beta Sigma chapter in the Northeast District in good standing became eligible for this award beginning at the close of the 2015 District Convention. Over the year, the list of eligible chapters was narrowed based on timely submission of district and national paperwork, then further narrowed by a review of all Chapter Summary Reports and Fall Activity Reports by the District Counselors. This year, there were nine eligible chapters named as finalists.

Changes to Proposed Expenses:

With a deficit of \$120 we made a cut of \$125 dollars to the off season travel budget. The proposal would make the off season travel expense go from \$300 to \$175. This line of the budget is a new addition so all officers have the ability to travel outside of travel season. Since we do not know how much would be needed for this line as it is brand new, we took the biggest cut from this allotted expense.

The committee also lowered the precinct allocated expense from \$600 to \$500. The Council allocated \$500 last year and spent \$450. By keeping this expense at it's

previous allocated amount, the budget still allows for the Council to spend more money than they did this year, but reduces the deficit in the budget.

Proposed additional line: The committee suggests an additional line in the expenses budget called "Open Allocations." The purpose of this new line would be an extra avenue for the entirety of the Council to decide where this money is most useful to use. It allows for more flexibility in the funds rather than delegating this money to a specific purpose.

Charge 1: Review the NED Constitution and 2015 Ways and Means Committee Report We reviewed the Constitution and the 2015 Ways and Means Committee Report. From here, we were able to tackle the other charges.

Charge 6: Brainstorm ideas for the 2016-2017 district fundraiser to be researched by the incoming TBS NED Secretary-Treasurer.

AND

Charge 8: Review the Activities of the NED Treasurer First we discussed our opinions on combining the offices Our process:

We read over the constitutional duties of each office and discussed the biggest roles of each office (Treasurer and Secretary).

Next, we inquired about the opinions of each officer: Both approved the combination stating they felt the duties would overlap well and are busiest during different times of the year

Collectively, we decided that at this point, we suggest combining the two offices' duties completely and then charge the next Ways and Means Committee to reevaluate the effectiveness of the combination.

Fundraisers to be researched:

We divided this charge into two sections; Travel season fundraisers, and year long fundraisers

Travel Season Fundraisers:

Photo booth: We can 1. Find a photographer who will provide this service at a cheaper rate with the promise of passing out business cards and promoting service or 2. Ask for Sister involvement to provide this service. This is something the Treasurer/Secretary could work on with the Districts Hosts.

Raffle Paddle: Similar to the paddle that is created by the Secretary for the Bingo Raffle but for a profit.

Chapter Calendars (2 year calendar): This can be either a year long fundraiser or Travel only. If a website is created, the calendar can be sold on the website. Another option is to create digital and paper copies so they can be sold in both forms. Turtle Keychains

NED Apparel (caps, shirts, etc.): This can be travel and all year round fundraisers as well.

Turtle Auction/Raffle: Sisters can offer up items to donate to be sold at the Auction. Bidding to Date a District Council Member to Dinner/Lunch: Similar to the pie Fundraiser but we are bidding for dinner/lunch dates throughout Travel Season 50/50 Raffles at all Meetings

All year round fundraisers

NED Merchandise: Create an NED website where merchandise is sold.

- Market place options: Etsy, amazon market (has an option to connect to a non profit), ebay, purchase form through google docs.
- Practical ways to incorporate them: can put a link on the NED website to connect the two, link the website URL to all emails.

Polar Bear Plunge Fundraiser: Have actives, alumni, etc, donate throughout the year. Each officer picks their goal amount that they will jump in for. For example, X will jump into the lake if we raise \$600. If we reach that amount, they have to take the plunge and run into a lake in early-mid spring.

Charge 7: Create a list of fundraisers that don't need financial support from the band program.

Game Day Bandanas

Auction (Services on and off campus): Reach out into the community and to the general campus community to auction off Services.

Plant Sale

Yankee Candle Fundraiser: No down payment. 40% of every sale Lincoln to Lincoln: Send a penny (or picture of a penny) and request a \$5 bill back (a lincoln). This can be advertized to not only the sisterhood alumni but to band parents and marching band alumni as well. If specific to sister alumni, make it a history project as well and ask for some stories about when they were active!

Charge 4: Match all Joint Line Items with Kappa Kappa Psi if necessary. There were no joint lines.

ORGANIZATION AND STRUCTURE

1.1 General

| 1.101 | The name of this organization shall be the Northeast District of Tau Beta Sigma. |

| 1.102 | This document establishes and prescribes the authorized regulations pertaining to the functions and operations of the Northeast District of Tau Beta Sigma. |
| 1.103 | The Northeast District of Tau Beta Sigma recognizes the Northeast District of Kappa Kappa Psi as an equal affiliated organization with a similar purpose, function, and role in the college and university band setting. |
| 1.104 | The current edition of <i>Robert's Rules of Order—Newly Revised</i> shall govern the entirety of all meeting components of the District. |
| 1.105 | All references to gender shall refer to individuals of both genders. |

Rationale:

- For 1.101 The name of the national organization is Tau Beta Sigma, as outlined in the national constitution (NC 1.101), and the district name is outlined in NC 5.101. If it's in the national constitution, it doesn't need to be in the district constitution.
- For 1.101- Addition of Standard Operations Procedure description for clarity
- For 1.102 Keep this with slight edits, as outlined below.
- For 1.103 This is outlined in NC 1.104, with the national organizations of Tau Beta Sigma and Kappa Kappa Psi recognizing each other as equal affiliated organizations.
- For 1.104 This is outlined in NC 1.107.
- For 1.105 We are removing all references to gender from the constitution this year.

New Text:

- 1. Organization and Structure
 - 1.1 This document (the "District Constitution") establishes and prescribes the authorized regulations pertaining to the functions and the operations of the Northeast District of Tau Beta Sigma (the "District"). This document is an extension of the regulations prescribed by the National Constitution of Tau Beta Sigma, which shall supersede all contents of this document.
 - 1.101 The Standard Operating Procedures ("SOP") is a living document maintained by the district council, counselors, and the district through the Jurisdiction Committee that outlines, in detail, district operations, roles and responsibilities of each officer, parameters for running for district office or bidding to host a district event, and any other functions pertaining to the district that are not described in the District Constitution. This document is meant to support the constitution, can act as a reference when needed, and will be located on the district website for complete transparency.

1.2 Governance

- 1.201...... The governing body of the Northeast District of Tau Beta Sigma shall be all Chapters of the Sorority meeting in regularly called conventions of the Chapters in the Northeast District as described in Part 5 of the National Constitution. Chapters who are not in good standing with the National Headquarters shall not be included as part of the governing body.
- 1.202...... The administrative body of the Sorority shall be the District Council, composed of all the District Officers. The District Counselor shall serve as an administrative officer.
- 1.203...... Members of the Northeast District should be in compliance with the National Constitution regarding membership status.
- 1.204...... More than fifty percent of all officially seated Delegates and proxies and at least half of the District Officers shall constitute a quorum to conduct business.

Rationale:

- For 1.201 This is outlined in NC 5.7. If it's in the national constitution, it doesn't need to be in the district constitution.
- For 1.202 This is outlined in NC 5.4.
- For 1.203 This is directly referring to the national constitution and doesn't need to be included.
- For 1.204 This is outlined in NC 5.605.

No new text needed.

1.3 Constitution Adoption

- 1.302...... This Constitution was officially adopted at the annual Convention of the Northeast District, held in 1987.
- 1.303...... This Constitution was officially revised at the annual Convention of the Northeast District held March 14-15, 2015 at West Chester University. It becomes effective immediately upon revision, and supersedes all previous editions.

1.4 Constitutional Amendment

- 1.402...... Corrections to spelling, grammar, and numbering that do not affect the content of the Constitution may be made at the discretion of the Parliamentarian and shall not require a vote by Convention Delegates.

Rationale:

- For 1.301 We included this in the new DC 1.1 above.
- For 1.302 This is a piece of history and can be included in the district's historical archives. It doesn't need to be in the constitution.
- For 1.303 The first sentence can be included in the district's historical archives. The second sentence is incorporated into the new text below.

- For 1.401 and 1.402 These are incorporated into the new text below. And the Parliamentarian will no longer be included in the district constitution (moving to the standard operating procedures, or SOP).
- (1.4 below was moved from the precinct meeting section.)

New text:

- 1.2 Any and all previous versions of the District Constitution along with any and all amendments shall become void and are superseded by this document. Proposed amendments to the District Constitution shall be presented in writing at District Conventions and shall be referred at once to the Jurisdiction Committee, which shall report thereon at the same convention. An amendment shall be declared adopted upon a two-thirds (%) favorable vote by the convention delegation.
- 1.3 The District Council, upon unanimous agreement, shall be authorized to correct spelling, grammar, numbering and other technical changes to the District Constitution as may be necessary to reflect the intent of the District. A record of all changes made during the year shall be presented to the Jurisdiction Committee at the subsequent District Convention.
- 1.4 The Northeast District shall be comprised of three regions called Precincts. The Northern Precinct includes chapters in Connecticut, Maine, Massachusetts, New Hampshire, New York, Rhode Island, and Vermont. The Central Precinct includes chapters in New Jersey, Pennsylvania, and West Virginia. The Southern Precinct includes chapters in Delaware, the District of Columbia, Maryland, and Virginia.

DISTRICT COUNSELOR

2.1 General

See National Constitution, Part 5, Section 2.

Rationale:

• For 2.101 - District counselors are governed by the national constitution, not the district constitution. The counselor's award requirements will be moved to the SOP.

DISTRICT OFFICERS

3.1 General

See National Constitution, Part 5, Section 3.

Rationale:

For 3.101 - This year we are changing the district council structure to four positions only, as listed in the new text below. Please see separate rationale document for more information. (Link:

New text:

2. DISTRICT OFFICERS

2.1 The officers of the District shall be District President, District Vice President of Membership, District Vice President of Special Projects and District Secretary-Treasurer, collectively known as the District Council.

2.101 Candidacy requirements for District Office will be outlined in the SOP and within the guidelines of the national constitution.

3.2 Candidacy

See National Constitution, Part 5, Section 3.

- 3.201...... A candidate for District Office shall be an Active member of a Chapter in the Northeast District, regardless of permanent residence when elected.
- 3.202...... A Candidate for District Office shall have completed one (1) semester of Active membership in the Sorority and served as an officer or head of a committee.
- 3.203....... A Candidate who wishes to be slated for District Office must submit six (6) copies of the following to the Nominations Committee; two (2) copies of each must also be submitted to the District President by the close of opening separate session the first day of District Convention, for a total of eight (8) paper copies.
 - a. A letter of intent.
 - b. One (1) letter of recommendation from the Chapter.
 - c. One (1) from either the Chapter's Sponsor or Director of Bands.
 - d. A resume of her activities and qualifications.
 - e. A summary that explains her eligibility for District Office, making sure her qualifications are in conjunction with the District and National Constitutions.
- 3.204...... In addition, the Candidate must also submit a one page summary of their platform for each Delegate. If in the event the Candidate may miss opening separate session, she may mail the copies of her packet and the copies of her one page summary to the District President.
- 3.205...... The Candidate also must submit her completed packet electronically to the District one (1) week prior to District Convention.

Rationale:

• This section will be moved to the SOP and updated to reflect current practices.

- For 3.305 This is a procedure that is outlined by national headquarters and will be included in the SOP.
- For 3.306 This will be moved to the SOP.

3.4 Duties

See National Constitution, Part 5, Section 3.

3.401..... The responsibilities of the District Council shall be as follows:

- a. To travel and visit Chapters.
- b. To correspond with National, District and Chapter officers on a regular basis including electronic, virtual, and in person visits.
- c. To attend and run Precinct workshops.
- d. To write articles for The Podium and "Northeast Notes."
- e. To execute any other projects that the District Council undertakes.
- f. To submit a report of activities conducted during their term of office at each regularly called District Convention.
- g. To submit an activities report for each issue of "Northeast Notes."
- h. All District Officers are required to submit proper paperwork for reimbursement as deemed appropriate by the District Counselor, District Treasurer, and National Headquarters.
- To maintain groups for correspondence and discussion via listservs, forums, or social media.

Rationale:

• For 3.401 - These responsibilities will be agreed upon by the district council and counselors each year and outlined in the SOP.

No new text needed.

3.402...... The responsibilities of the District President shall be as follows:

- a. To request applications for the District Webmaster no later than thirty (30) days prior to the start of District Convention, and to appoint this position no later than thirty (30) days after convention.
- b. To request applications for the District Parliamentarian by November 1st, and to be appointed by December 1st.
- c. To request applications for the District Committee Chairs no later than thirty (30) days prior to the start of District Convention and to provide materials and instructions to chairs no later than fourteen (14) days prior to the start of Convention.
- d. To supply each Chapter with one (1) copy of all tentative charges at least twenty—one (21) days prior to the District Convention.
- e. To attend the District Presidents' meeting prior to National Convention and sit as the Northeast District Delegate at the National Convention, or to attend the National District Leadership Conference, dependent on the year in office.
- f. To send Candidates for District Office Candidate information and District
 Office information material at least thirty (30) days prior to the District
 Convention.
- g. To award the Most Improved Chapter and the District Spirit Award at each Northeast District Convention. The qualifications for these awards shall be left to the discretion of the District Council.
- h. To collect all of the chapter constitutions for review by the Counselor.

Rationale:

• For 3.402 - These responsibilities will be agreed upon by the district council and counselors each year and outlined in the SOP. We do, however, think it's

important to include a brief outline of the position.

New text:

2.2 The District President shall preside over all meetings of the District and will be the official representative of the District at all Sorority functions. The District President shall be a non-voting member of all District committees, and shall appoint committee chairs and any appointed positions subject to approval of the District Counselors.

3.403...... The responsibilities for the District Vice President of Membership shall be as follows:

- a. To work with the Tau Beta Sigma National Vice President for Colonization and Membership and the District Vice President of Kappa Kappa Psi towards membership development of the existing Chapters.
- b. To serve as Advisor to the Membership Committee.
- e. To notify Chapters semi—annually regarding colonization processes within the District. The Vice President of Membership is also responsible for communicating dates of colony degrees to all Chapters within the District at least two (2) weeks prior to the degree.
- d. To collect and review Chapter Membership Education Packets for input and future reference.
- e. To collect Chapter Membership Education Packets for input and to be reviewed by the Counselor in advance of an approval date of September 30.
- f. To maintain and make available a database of programs for Post Initiate Education and Project Good Member.

Rationale:

• For 3.403 - These responsibilities will be agreed upon by the district council and counselors each year and outlined in the SOP. We do, however, think it's important to include a brief outline of the position.

New text:

2.3 The District Vice President of Membership shall preside over all meetings of the District in the absence of the District President. They shall be responsible for facilitating District programming related to membership education.

3.404...... The responsibilities of the Vice President of Special Projects shall be as follows:

- a. To maintain and advertise the requirements of the Life Membership
 Scholarship, Music Education Awareness Award, All Star Service Award, Unsung
 Hero Award, and Phenomenal Sister Award. The Life Membership Scholarship
 shall be due at least two weeks prior to the start of District Convention and
 shall be awarded at District Convention. The remaining awards shall be due at
 least two (2) weeks prior to the start of District Convention and shall be
 awarded at District Convention.
- b. To work with the District Member at Large of Kappa Kappa Psi to arrange a joint event per year.
- c. To serve as Advisor to the Programs Committee.
- d. To maintain Project Protect Music, incorporating and developing ways for

Chapters and the District to protect and support music programs in our region.

- e. To facilitate Chapter participation with all national programs.
- f. To promote and help maintain all District programs and/or create new programs if deemed necessary.

Rationale:

• For 3.404 - These responsibilities will be agreed upon by the district council and counselors each year and outlined in the SOP. We do, however, think it's important to include a brief outline of the position.

New text:

2.4 The District Vice President of Special Projects shall be responsible for designing and implementing District programs, awards, and historical projects, as determined by the District Council.

3.405...... The responsibilities of the District Secretary shall be as follows:

- a. To collect summer contact information from each chapter in the District for distribution to all District Officers and the District Counselor.
- b. To distribute a roster including addresses and phone numbers of all Chapter Presidents and/or Secretaries within the District to the Chapters, no later than October 1.
- c. To provide documented notification of the District Convention dates to all Chapters in the District, their Chapter Sponsors, the District Officers, the District Counselor, NEDAA, the TBSAA, the National Officers, the members of the Board of Trustees, and the National Headquarters at least ninety (90) days prior to the close of registration.
- d. To record and publish the minutes of the District Convention and to distribute these to all Chapters in the District, the District Officers, the District Counselor, the National Officers, and the National Headquarters no later thirty than (30) days following the close of convention. According to the Table of Contents, the District Minutes should include:
 - i. Separate and Joint Session Minutes.
 - ii. Award Recipients.
 - iii. Committee Workshops.
 - iv. Counselor's Report.
 - v. District Officers' Reports.
 - vi. Yearly Chapter Reports.
 - vii. Delegate Committee Assignments and Committee Charges.
 - viii. Separate Committee Reports.
 - ix. Joint Committee Reports.
- e. To award the Golden Typewriter Award at each Northeast District Convention.

 The qualifications for this award shall be left to the discretion of the District Council.
- f. To collect materials from the seated proxies immediately following the closing joint session and to send those materials to the respective chapters within one (1) week of the close of the District Convention.

- g. To assist in improving inter-Chapter relations.
- To take minutes at all meetings of the District Council and distribute them to the District and National Councils.
- . To serve as the Advisor to the Sisterhood and Spirit Committee.

3.406...... The responsibilities of the District Treasurer shall be as follows:

- To keep an itemized report of receipts and disbursements to be included in the yearly report.
- b. To act as Advisor to the Ways and Means Committee.
- c. To organize and implement District fundraisers.
- d. The Treasurer shall submit a current budget update and the proposed budget for the next year to the District Counselor, the District President, and the Ways and Means Committee at District Convention.
- e. To submit a separate end of the year fund-raising report to the Ways and Means Committee, stating the fundraising projects undertaken during the year and their effectiveness.
- f. To collect the Delegate Fee by the start of District Convention and implement a late fee of five (5) dollars if deemed necessary.
- g. To maintain and make available a Fundraising Activity Forum on the District website.
- h. To provide Chapters with a sample budget and to collect Chapter budgets and provide constructive feedback.
- To collect reimbursement forms and receipts for any District expenses incurred and submit approval of reimbursement to the District Counselor and National Accountant within thirty (30) days.

Rationale:

• For 3.405 & 3.406 - These two positions will be combined. Responsibilities will be agreed upon by the district council and counselors each year and outlined in the SOP. We do, however, think it's important to include a brief outline of the position.

New text:

2.5 The District Secretary-Treasurer shall record, publish, and distribute the minutes of all District meetings. They shall be responsible for controlling the receipts and disbursements of all District monies and keeping a ledger of financial transactions.

- i. To serve as the Advisor to the Alumni Affairs Committee, and to invite a representative of NEDAA and TBSAA to be present at the Committee meeting.
- To monitor the online publication and "Northeast Notes" in conjunction with the Kappa Kappa Psi NED Historian/Alumni Liaison and to publish a biannual edition of the publication as per deadlines in 9.102.



5.1 General

5.101...... District funds may be used for the following purposes:



The following joint committee was active and submitted an oral report to the joint delegation along with their written statement below: Convention Site and Publication. Note, no special committees were called into existence by the District Presidents.

Joint Convention Site & Publication Committee Report 2016

Committee Chair Sonya Osei (Tau Beta Sigma - Theta Pi) Committee Chair Paula Batoon (Kappa Kappa Psi - Kappa Upsilon) Advisor Dr. Kathryn Kelly

Good Afternoon Brothers and Sisters of the NED,

We would like to begin the final report of the Joint Convention Site and Publication Committee by thanking all who sat on the committee and our advisor, Dr. Kathryn Kelly. Everyone's participation and feedback was essential in our committee's productivity in discussing the charges delegated to us. We are confident that our recommendations for the 2017 District Convention site will be in the best interest of the District.

The charges for the 2016 Joint Convention Site and Publication were as follows:

- 1. Review the NED Constitution and the 2016 Joint Site Committee Report
- a. Make any recommendations for the changes to bid requirements since there may be some that are not needed if a chapter wants to hold a hotel bid
- 2. Review all bids for the NED Convention 2017 to ensure they satisfy the constitutional requirements.
- a. Our parliamentarians will be doing this first, but it will be good for the Committee to do this as well. Notify the District Presidents immediately if a bid is found to not satisfy the requirements.
- 3. Hold in-person presentations for all bids.
 - a. Schedule these right after the opening joint session.
- 4. Discuss and recommend a 2017 Convention Site.

The 2016 Joint Convention Site and Publication Committee discussed the constitution as it stands, reviewing Convention site sections, to ensure that phrasing and wording were synonymous with Bid Requirements. The committee also discussed improving the bid submission process to make it easier for both the bidding school and next year's Joint Convention Site and Publication Committee.

The charges for the District Council of 2016-2017 are as follows:

- 1. Work to improve the bid submission process in the following ways:
- a. The bid shall be required to provide a more detailed budget of both chapters' financial activities, including current financial activities and an accurate report of projected convention expenses.
- b. The bid shall also be required to provide membership statistics which state how many active and conditional members are in the chapter, as well as Membership Candidates.
- c. Past bids shall be accessible online to provide a template for potential bidders and to increase interest in bid submission.
- d. The bid shall be electronically submitted to make the bid submission process easier.
 - i. The electronically submitted bid shall be distributed to the 2017 Joint Convention Site and Publication Committee chairs and the members of the committee.
- 2. Increase interest in hosting District Convention and Precinct Meetings by educating the NED on how a bid should be made and how a convention should be run.
- 3. Give a list of concerns that the committee has determined to the host chapter of the following year's convention.

The charges to the 2017 Joint Committee are as follows:

- 1. Review and recommend ways to make the bid process easier for bidding schools, the chapters in the Northeast District, and the Council.
- 2. Continue to work to make the quality of submitted bids the best and most detailed it can be.
- 3. Review and recommend ways to increase interest in hosting convention.

The 2016 Joint Convention Site and Publication Committee, advisor, and committee chair wish to thank Syracuse University for submitting a quality bid and for giving a quality presentation to both the committee and the NED. Furthermore, we hope that the future council and committees continue to improve on the bid process and increase interest in hosting a District Convention.

SECTION NINE: TBS NED Constitution

1. ORGANIZATION AND STRUCTURE

- 1.1 This document (the "District Constitution") establishes and prescribes the authorized regulations pertaining to the functions and the operations of the Northeast District of Tau Beta Sigma (the "District"). This document is an extension of the regulations prescribed by the National Constitution of Tau Beta Sigma, which shall supersede all contents of this document.
- 1.2 Any and all previous versions of the District Constitution along with any and all amendments shall become void and are superseded by this document. Proposed amendments to the District Constitution shall be presented in writing at District Conventions and shall be referred at once to the Jurisdiction Committee, which shall report thereon at the same convention. An amendment shall be declared adopted upon a two-thirds (%) favorable vote by the convention delegation.
- 1.3 The District Council, upon unanimous agreement, shall be authorized to correct spelling, grammar, numbering and other technical changes to the District Constitution as may be necessary to reflect the intent of the District. A record of all changes made during the year shall be presented to the Jurisdiction Committee at the subsequent District Convention.
- 1.4 The Standard Operating Procedures ("SOP") is a living document maintained by the District Council, Counselors, and the District through the Jurisdiction Committee that outlines, in detail, District operations, roles and responsibilities of each officer, parameters for running for District office or bidding to host a District event, and any other functions pertaining to the District that are not described in the District Constitution. This document is meant to support the constitution, can act as a reference when needed, and will be located on the District website for complete transparency.
- 1.5 The Northeast District shall be comprised of three regions called Precincts. The Northern Precinct includes chapters in Connecticut, Maine, Massachusetts, New Hampshire, New York, Rhode Island, and Vermont. The Central Precinct includes chapters in New Jersey, Pennsylvania, and West Virginia. The Southern Precinct includes chapters in Delaware, the District of Columbia, Maryland, and Virginia.

2. DISTRICT OFFICERS

- 2.1 The officers of the District shall be District President, District Vice President of Membership, District Vice President of Special Projects and District Secretary-Treasurer, collectively known as the District Council.
- 2.2 Candidacy requirements for District office will be outlined in the SOP and within the guidelines of the National Constitution.
- 2.3 The District President shall preside over all meetings of the District and will be the official representative of the District at all Sorority functions. The District President shall be a non-voting member of all District committees, and shall appoint committee chairs and any appointed positions subject to approval of the District Counselors.
- 2.4 The District Vice President of Membership shall preside over all meetings of the District in the absence of the District President. The District Vice President of Membership shall be responsible for facilitating District programming related to membership education.
- 2.5 The District Vice President of Special Projects shall be responsible for designing and implementing District programs, awards, and historical projects, as determined by the District Council.
- 2.6 The District Secretary-Treasurer shall record, publish, and distribute the minutes of all District meetings. The District Secretary-Treasurer shall be responsible for controlling the receipts and disbursements of all District monies and keeping a ledger of financial transactions.

3. FINANCES

3.1 The account for the Northeast District of Tau Beta Sigma shall be handled by the National Headquarters. The District Council shall determine the use of District funds subject to approval by the District Counselors.

4. MEETINGS & COMMITTEES

4.1 There shall be an annual meeting of the District, known as the Northeast District Convention. The location of the next Convention shall be determined at each

preceding Convention. In the absence of a selection at that Convention, the District Counselors and Kappa Kappa Psi Northeast District Governors shall determine the next Convention site.

- 4.2 Each Chapter shall submit a Delegate form and submit a Chapter annual report to have a Chapter Delegate or chosen proxy seated at District Convention.
- 4.3 Standing committees appointed for the District Convention shall be: Nominations Committee, Joint Convention Site and Publications Committee, Membership Committee, Jurisdiction Committee, Programs Committee, Ways and Means Committee, and Sisterhood and Spirit Committee. Special committees may be appointed at the discretion of the District President subject to approval by the District Counselors.
- 4.4 The following criteria must be included in bids submitted by Chapters wishing to host a District Convention:
 - a) Letter from Administration, such as Office of Student Affairs or Office of the President
 - b) Letter from both Chapter Sponsors
 - c) Letter from Director of Bands
 - d) Overview of meeting facilities, such as occupancy, setup options, pictures of rooms, campus maps
 - e) Projected Accommodations, such as hotels and rates
 - f) Financial summary from each Chapter and Joint Chapter, if applicable, to include:
 - i) Current balance
 - ii) Projected balance at the time of the scheduled District Convention
 - iii) Projected fundraising goals
 - g) Tentative Budget
 - h) Membership Status Statistics (Active, Associate, Conditional, etc.)
 - i) Available Dining Options
 - j) Parking
 - k) Transportation including: driving directions, local airports, train stations, public transportation, and bus depots
 - l) Contact Information (Electronic Mail and Telephone)
 - m) Preferred and Alternate Dates
 - n) Overview of technology options such as what resources are available
 - o) Parking

- 4.401 Each host Chapter shall compile a chronological operations manual of information, which details their activities during the year prior to and including the District Convention, as well as contact information for the Convention committee chairs. This operations manual shall be given to the new District Convention host no later than four (4) weeks after District Convention.
- 4.402 The date of the District Convention shall be determined by the host Chapter with approval by the District Counselor(s) and Governor(s). The host chapter must notify the Chapters in the District, each member of the Joint District Council, the District Counselor(s), the District Governor(s), each National Officer, and National Headquarters of the date of the District Convention within sixty (60) days of notification of being chosen host.
- 4.403 The host Chapter shall be responsible for submitting a post-convention budget report, and any profit realized by the host Chapter during the District Convention from District Convention Fees to the District Treasurer for deposit into the District account. The report and profit must be received by June 1st.
- 4.404 Two (2) hard copies of the completed bids for District Convention must be submitted to the District Councils by the final call for Convention bids in the first joint session of Convention. An electronic completed bid for District Convention must be received by the District Councils one (1) week prior to Convention. Completed bids must include each section that is outlined in 4.4.
- 4.405 The host Chapter will provide a finalized list of registered Convention attendees with Chapter Designation and status in order of Chapter Designation to the District President and Secretary-Treasurer at the close of registration.
- 4.5 There shall be an annual Precinct Meeting within each Precinct of the District. The location of the next Precinct Meeting shall be determined at each preceding Precinct Meeting. In the absence of a selection at that Precinct Meeting, the District Counselors and Kappa Kappa Psi Northeast District Governors shall determine the next meeting site.
- 4.501 Completed bids for Precinct Meetings must be received by the final call for Precinct bids in the first joint session of the current Precinct Meeting. Two (2) hard copies of the bid must be submitted to the District Councils.
- 4.502 The following criteria must be included in bids submitted by Chapters wishing to

host a precinct meeting:

- a) Letter from Administration, such as Office of Student Affairs or Office of the President
- b) Letter from both Chapter Sponsors
- c) Letter from Director of Bands
- d) Overview of meeting facilities, such as occupancy, setup options, pictures of rooms, campus maps
- e) Projected Accommodations, such as hotels and rates
- f) Financial summary from each Chapter and Joint Chapter, if applicable, to include:
 - i) Current balance
 - ii) Projected balance at the time of the scheduled District Convention
 - iii) Projected fundraising goals
- g) Tentative Budget
- h) Membership Status Statistics (Active, Associate, Conditional, etc.)
- i) Available Dining Options
- j) Parking
- k) Transportation including: driving directions, local airports, train stations, public transportation, and bus depots
- l) Contact Information (Electronic Mail and Telephone)
- m) Preferred and Alternate Dates
- n) Overview of technology options such as what resources are available
- o) Parking
- 4.503 The Joint Northeast District Councils of Kappa Kappa Psi and Tau Beta Sigma shall then meet to determine the location of the next Precinct Meeting.
- 4.504 In the absence of a selection by District Convention, the selection process of the following year's precinct meeting will be left to the jurisdiction of the Joint Northeast District Councils. The Councils will consider the following four (4) items and are obligated to select a host chapter within ninety (90) days:
 - a) Timely completion of chapter's district and national paperwork.
 - b) Officer's impressions of potential host chapters.
 - c) Pursuing at least two (2) potential host chapters.
 - d) Chapter's willingness to host.
- 4.505 Each Chapter selected to host a Precinct Meeting shall publish, in writing, the date of the meeting, as well as the preliminary housing and registration information at minimum to all Chapters and colonies within the District, all Nationally recognized

Alumni Associations, all District Council members, the District Counselors, and all National Officers by November 1 of the year preceding the Precinct Meeting. Said chapters will also publish, in writing, the final housing and registration fee information, as well as detailed directions and maps by January 15 of the year of the Precinct Meeting and distribute as above.

5. JOINT CHAPTER

5.1 The joint Chapter of the Northeast District of Tau Beta Sigma and Kappa Kappa Psi shall be comprised of the seated Delegates of each organization meeting together in Convention. Sessions of the joint Chapter shall be governed by the presiding Officers of Tau Beta Sigma and Kappa Kappa Psi jointly.

SECTION TEN: CHAPTER REPORTS

Each chapter is asked to submit a one-page review of their activities from the past year. The following reports were received by the opening gavel of separates session.

Beta Eta

As we transition into a new era working without our fellow Brother chapter, we are trying to refine and decide what service we will continue to do, what we could do that the Brothers used to do, and what we had to decide what not to do. We continued to do our Penny Wars that we do every year and gave the money to Laurel High School, a local high school whose music program was in need. Our Brothers used to provide the service of a Supply Store for band members to buy more lyres, lyre pages, and reeds throughout the semester. We decided to tackle this service to continue providing the ability for band members to easily access important things like reeds and valve oil. One service project that we are really excited about is our Jazz Showcase! Since some of the Jazz ensembles are not funded by the School of Music, we figured we should try to plan a project to raise money for them. It will be a night of Jazz where performers will be free to perform whatever jazz pieces they want and we will be taking donations from attendees.

As for membership, we have also worked really hard to revamp our topics and how we teach the information to the MCs. We are now giving lessons to teach the information to the MCs and the actives. We are finding new ways to teach the information including telling everyone the different tricks we have all used in the past to remember the information better. This is also an exciting semester because have our first male MC going through the process! This is something that has never happened in Beta Eta history and we are all really excited about him and how he will do.

For fundraising, we have one main way we get money, which is through working retail at the Baltimore Ravens stadium. We have two stands that we run during a couple of home games during the semester that are run by two Sisters apiece. We get about 10% of our profits at every game and we end up making most of our money from this method of fundraising. We have an Amazon Smile account where people can donate a small amount of their purchase's to us. Last year, our chapter ran a district fundraiser where we made different bows for people to buy. We plan on having this same districts fundraiser again, but we are planning on trying to include clip-on bowties for people to buy as well.

Gamma Kappa

This year at Gamma Kappa, we have been continuing with our expansion of our service, but are trying to work to focus equally on service and membership. In the fall we do a large variety of service projects to help our band, community bands, and the music department. For our own band we help at each rehearsal with the set up and breakdown of the tasks, distribute uniforms, cleaned out the band trucks, cleaned the guard closet, maintained uniforms during the season, helped in all aspects of serving meals at football games, among other things. For the music department, we maintained a bulletin board, painted the remainder of the music building stands, and held receptions jointly with the brothers after concerts. For the community assisted at high school competitions, help tech local marching bands, and went to a local elementary school for a play-along. This spring we are just starting getting into our typically projects, and have a few great ones that we are looking forward to.

The music department has held both the local regional festival and festival that our own music department has put on called first chair honor band. Other than helping at both of these events, we've help with audition days, and continued in our maintenance with the bulletin boards for the music department. For our community, this spring we are currently planning another play along, are hoping

to bring a pep band to a local nursing home, we've made scarves for the local homeless community, and are working on pairing with a local Boy Scout troop to help them complete a music merit badge. For our own band we've helped break down from pep band rehearsal, collected uniforms, and will help serve food at the university's spring football game. We also try to do our part by donating finances to our bands Tower Project to help build a Band Tower, and by also donating money to band students participating in our 18-hour long dance marathon to benefit the local Children's Hospital.

While we are still working on more fundraisers for the chapter, we have been dedicating to raising money with our candle fundraiser and has been a big success so far. We hope to have more fundraisers after spring break.

We have also assisted our marching band within the past season and have even assisted the Cory Band as they visited Mansfield two weeks ago. The Cory Band was a delight and all sisters of the Gamma Chi chapter helped them through the whole day with the assistance of Epsilon lota chapter of Kappa Kappa Psi. For upcoming service, we plan on assisting an animal shelter around the Wellsboro area.

Gamma Omega

The Gamma Omega chapter at the University of Pittsburgh has been very busy over the past year. In terms of service, we have completed hundreds of hours of service to our band and our community. In addition to handing out and collecting uniforms, an important and well-liked service event in the fall is Pitt Band Thanksgiving which is a Thanksgiving dinner put on by the sisterhood for the entire marching band before practice one of the days before Thanksgiving; the proceeds go towards a local food bank. This year we have also done community service through Pitt Make a Difference Day which is helping out in communities by cleaning up trash or anything else to make the community look better and through Girl Scouts by helping the girls to get their Music Badge. We have also helped out at multiple indoor guard and percussion shows throughout the area to promote music in the high schools.

Gamma Omega has definitely expanded their membership throughout the past year. We had 6 membership candidates in the fall and currently have 10 membership candidates right now. Throughout the year, each membership class got to get to know the sisterhood by hosting their own social for the sisterhood and by attending different social and service activities with the sisters. Our VPM this year started to implement post-membership questions. These questions were made by the membership candidates and ranged from trivia about the sisterhood to the reasons why we love it. This has helped our membership candidates to learn more about what being a sister is about and has helped them to bond with the sisters.

Throughout this year, Gamma Omega has raised a substantial amount of money. In the fall, we made Pitt Band calendars for the entire band and also sold blankets; both of which were great Christmas gifts and brought in money for the sisterhood. We also host a plant sale in the spring by selling bamboo plants for the entire university. Other fundraisers that we do is Pittsburgh Popcorn which all of the sisters seem to love and supplying pizza for band members before practices in the fall. Overall, the Gamma Omega chapter has done a lot over the past year and looks forward to what is coming ahead of

Delta Delta

In the Fall semester, Delta Delta focused on improving our communication. We opened up discussion during meetings, wrote pro/con lists on the board, created bonding activities to do during meetings, and we discussed and analyzed ritual together. Some of these activities included our 7 new sisters as they were going through their process. Including them in the bonding activities strengthened the relationship between the actives and the MCs, and showed them that we are more than a service

group. As for service in the Fall, we had 3 Women in Music speakers, provided daily service for the band through lining our practice fields and setting up chairs, passed out water and picked up trash during band trips, and held receptions for the music department performances.

The sisters of Delta Delta were extremely flexible during the Fall semester, as they were presented with many changes. The chapter passed constitutional changes that decreased the size of the executive board from 10 positions to 8, as well as decreasing the amount of chair positions from 7 to 3. In addition, the Fall Membership Class exposed flaws in our process and how we teach it. This lead to a complete revamp of the process. Along with membership big changes, two of our members went inactive. This lead to a lot of discussion about why we are sisters, what the bond means to us, and that it is okay if someone decides that this is not for them.

Moving forward, the sisters are not taking a Spring class like we usually do, and are putting more emphasis on casual bonding. We recognize that though our communication has improved dramatically, it can't stop here. The more we enjoy each other's company and are able to have fun together whether it is getting lunch or studying, the more comfortable we all will be. There is a "Down to Lunch" app that the sisters have been using a lot, and it notifies contacts about where someone is and anyone who is "down to chill" have that opportunity to do so. Aside from strengthening our bond, we chose to focus on service this semester. We continue to have daily service by setting up chairs for the Concert and Sports bands as well as continuing receptions for the music department. We have 3 Women in Music speakers and music department audition days we co-facilitate with Epsilon Nu. In an effort to be better leaders and community members, we are making a trip to Waltham to help Girl Scouts earn their music badges, having a Stonewall Center workshop to learn about LGBTQIA culture, and we also stuffed and donated purses to the Women's Shelter in town. Later on in the semester, we plan on creating a video about why we continue to participate in band and send it to public schools in the area to promote music participation. Delta Delta has grown so much over the past year, and we are eager to continue to become a stronger and more successful chapter!

Delta Nu

Over the past year, Delta Nu has been doing really well in the fundraising world! We have been working hard to keep our bank account healthy and going strong. Our newest fundraiser is face painting at our home hockey games. We are a huge hockey school, so home games bring in a ton of fans from around the state! Through a connection with our life member, Elyse Bronson, we paired up with Friends of Maine Hockey to carry out this project. We split the proceeds half and half for each night and have made about 200 dollars a month doing it. On top of that we've continued our Mac and Cheese tabling in our music building and people are LOVING it! Overall, this year we are working on bigger and broader fundraisers rather than small and complicated things. We hope to establish our chapter more and have people know who we are around campus.

This past year in service for Delta Nu has been quite busy and full of new and expanding ideas. As we have in the past, the sisters have provided breakfast to our marching band during the Saturday morning practices since the dining halls are not open by the time rehearsal begins. During the marching season, our uniform chair leads the service of the maintenance of the marching band uniforms. At the end of the season, the sisters and brothers plan and provide a banquet for the members of the band. We have also done a clean up for one of the University of Maine's piano teacher, this includes all internal cleaning of her residence. For the Screamin' Black Bear Pep Band, the sisters provide our "spirit pack", a well sized duffel bag filled with many decorations for the band to show school spirit. A newer service that doubles as a fundraiser is face painting at the home hockey games, this is a service to the fans and students. We have also assisted Leonard Middle School with the setting up and tearing down of their

concerts, both choral and instrumental, as well as attend their jazz band rehearsals to promote the continuation of music to the students. During what we call "Maine Day", the sisters of Delta Nu team up with the Epsilon Upsilon chapter of Kappa Kappa Psi to do a thorough cleaning of the Class of 1944 Hall. Every week we also work with the brothers to do stage work and audio recordings of the recital lab performances.

This year, Delta Nu initiated 8 MC's into the sisterhood. They had a very successful MC period. They held a basket raffle in which they raffled off baskets, one with homemade jams donated from one of our MC's, and the other with some handmade goods such as scarves and blankets. They did this at the symphonic band concert and were extremely successful, making around \$104. With this money, they were able to buy a handcart for symphonic band tour for the tubs we keep the folders in. In years prior, the librarian would have to carry these from the bus to each school we went to. They still have some money left and are looking to use some of it to clean the chairs that are outside of our recital hall in the music building. We have also added interview initiative for them. For different interviews they complete, they will earn a ribbon stripe in the colors of our flag. This year, we have had some of the biggest numbers for our MC's completing their interviews, although it is not required for voting rights. Before each degree, we have a ritual workshop where all our active sisters would discuss different aspects of the ritual and then we would run it so everybody knew what they were doing before we did it with the MC's. This semester, we are planning on having a sister jeopardy nights for our continuing membership education.

Delta Omicron

These are the things that the Delta Omicron chapter has been doing the past year, including service, membership, and fundraisers. The chapter has been very busy serving the bands and the community. The first thing we worked on was getting the new uniforms for the marching band organized and passed out. Every other Friday, the chapter served at a local high school's concession stand, AC Valley. We also ushered senior recitals and the different concerts on campus. We set up the stage for concerts and set up one day a week for the concert band rehearsals. Other things we do for the band is organizing the uniform room, and send the uniforms out for get dry cleaned and pressed. Not only do we serve the bands, but we try our best to help out the community. Some ways we do that are through adopt a highway, twice a year. We also go to a local animal shelter and help out there. We are also planning on participating in the campus wide community days and walking for Relay for Life this semester. We started our recruitment this year on September 14, and held events every Monday and Thursday. Some of the events included, dinner with the sisters game night, AC Valley, bingo night, and karaoke. Some things that we are working on as members of the chapter are strengthening our bond, and continuing our education of the sorority. Our sisterhood committee, which is in charge of planning events that bring all the sisters together, plan events throughout the year. Some of the events were a lock-in, a t-shirt letter exchange, Valentines Day party, and sisterhood library nights. The Delta Omicron chapter has done many fundraisers in the past year. Our most successful fundraiser was working Kennywood's Fright Night. Some other successful fundraisers were Appleicious, canning at Comet, a dining to donate with Applebee's and duct taping a professor to the wall.

Delta Omega

Over the course of this year, Delta Omega has been involved in several different service activities. During band camp prior to the beginning of classes, we have supplied snacks and ice pops during breaks for the band. Once the school year started, we began ushering all of the music ensemble concerts and student recitals, as well as providing juice and cookies for marching band after our halftime shows on the weekends. We visited the ASPCA to help out with cleaning and taking care of the animals. We worked at a pancake fundraiser at Applebee's where we served pancakes, sausage, and beverages to

customers. We helped Zeta Upsilon at the Allentown Collegiate Band Festival directing bands and traffic, set up tables during open houses at Bloomsburg University to talk to prospective students about the band program, and aided Central Columbia High School in running their County Band auditions. After the end of marching band, we organized uniform turn-in to send them to the dry cleaner's and then organized them again on their return. We organized two service projects, polishing instruments and writing letters to troops, which were executed nicely when we hosted Central Precincts with our Brother Chapter Zeta Alpha. For the remainder of this semester, we are continuing to usher and will be helping with Jazzfest and Stringposium, two programs set up to act as clinics and a great learning experience for local high school students. We are working on plans to host a Women in Music speaker, as well as Project Crescendo.

Delta Omega has grown immensely over the past few years, both in quantity and quality. With 21 active members this semester, we are really beginning to thrive. The size of our chapter really allows us to serve our bands as well as our community. We have developed several activities during our membership education process that facilitate bonding within the chapter. During these activities we learn fun facts about one another, eat meals together, and have study sessions where we brush up on our TBS information as well as our school coursework. We hold several workshops throughout the semester as well to keep everyone engaged in the activities of the Sorority. Marching band season is our main time for recruitment. This past fall we initiated six new sisters who have really helped strengthen our bond as a chapter.

Over the years Delta Omega has struggled with fundraising. Throughout this past year we have tried many different fundraisers. There are the ones that succeeded and those that failed. Our biggest fundraiser that is always a success is selling Krispy Kreme donuts. This is our best fundraiser because we offer a product that is not easy access to out students here at Bloomsburg University. We have also participated in several Dine to Donate fundraisers at local restaurants and have raffled off music-themed baskets at District Convention. Our chapter does pretty well with fundraisers but there is always room for improvement.

In the past year we have tried to remained focus on building our chapter in quality. We have been focusing more on what we can do better to help our chapter grow stronger. 10% of the total bill is donated to the chapter. We also have penny wars for band, and During our Halloween Dance we have a costume contest. We have raised more money this year because of our small changes than we have in the recent past.

Not only have we fixed the bond with our band director and staff, but we have created a close bond with Petersburg High School's band program. Last semester, we have had several fundraisers for not only our chapter, but for the Trojan Explosion Marching band. We also did a back to school drive for Petersbjrg High school. We have had many events for our band members to come out and unwind after practice as well as get extra help during the season. We may be a small chapter, but we do big things and are determined to continue doing them. August 20th, 2015: "Meal Time TAUsers"-Sisters made spaghetti dinners for band after a hard days work. August 20th, 2015: "Spartan Legion Talent Showcase"- Sisters hosted a show to display the different talents in the band. August 22nd, 2015: "Legion Social"- Sisters and brothers planned a social for the band after its two weeks of band camp. We've kept most of our projects from past years, but have also found new ways to provide service to our local band programs, improve our membership, and fundraise and save money as a chapter.

Providing service to Virginia Tech's music programs, local band programs, and our community has been our focus this year. We serve our marching band by helping our director with band camp, providing breakfast for the members on game days, and holding a field day for the members of the marching band to get to know one another at the beginning of the season. We also held one service day per semester where we, along with our Kappa Kappa Psi brothers, clean and organize our marching band building and instruments.
